The Inaugural International Women's Day Program (IWD Program) was held this past weekend to massive success. The IWD Program aimed to encourage female and non-binary students to get involved in within their legal degree, particularly in a competitions context.

Day 1 involved a Professional Skills Workshop, run by Simone Alexander (Professional Skills Executive) and Dr Lise Barry (Interim Dean of Macquarie Law School), wherein students were guided through the different competitions and how to do well in them. This was followed by a Careers Panel, with fantastic guests such as Intellectual Property Partner Nina Fitzgerald (Ashurst), In-house Legal Counsel Calli Tspidis (Foxtel Group), Dr Lise Barry (Macquarie University), Special Counsel Sonia Chandra (Danny King Legal) and Senior Associate Hayley Tibbie (JHK Legal).



Day 2 involved a focus in advocacy, with a Mooting Workshop hosted by Jaz Cremen (2021 Jessup Competitor) and Sydney Gale (ex-MULS Competitions Director), followed by a Demonstration Moot.
